	Outdoor Usage	Watering cans or buckets permitted at any time.
R1	Watering of established gardens	Use of hand-held hoses can be used for 10 minutes every second day, between 4.00pm and 9.00am on odd or even days matching house numbering system.
		All hand-held hoses must be fitted with an on/off nozzle.
		Other irrigation and unattended hoses banned.
R2	Watering of established lawns	Not permitted.
R3	Watering of new turf, lawns and gardens	Watering-in permitted for 30 minutes only on the day of establishment.
		Then 15 minutes every second day, between 4.00pm and 9.00am on odd or even days matching house numbering system for 7 days after the date of establishment.
		All hand-held hoses must be fitted with an on/off nozzle.
R4	Topping up and refilling of existing swimming pools and spas	Topping up permitted only if required to avoid structural damage, between 4.00pm and 9.00am on alternate days, matching house numbering using hand-held hose fitted with an on/off nozzle.
		Emptying and refilling of pools/spas not permitted.
R5	Filling of new swimming pools and spas	Permitted only if required to avoid structural damage.
		Prior approval of Council is required.
R6	Water play tools, toys and slides	Not permitted.
R8	Pet care/washing	Provision of drinking water permitted.
		Washing pets and pet pens with bucket permitted between 4.00pm and 9.00am.
		Use of hoses not permitted.
R9	Fountains, ponds, water features, outdoors aquaria	Operation or top-up not permitted except to maintain fish life.
		Installation and filling of new facilities not permitted.
R10	Washing of driveways, paved areas, rooves, walls, windows and	Not permitted except for health and safety reasons by registered cleaning

R11	Car/vehicle washing	Watering cans or buckets permitted, Efficient high-pressure, low flow rate
		cleaners with trigger control permitted for 5 minutes only between 4.00pm and 9am on odd or even days matching house numbering system.
R12	Washing of boats, boat motors and trailers used in salt water	Permitted for 5 minutes at any time.

		Log of water use required.

P2	Public water play facilities	Operation or top up not permitted unless water is recirculated.
		Log of water use required.
P3	Irrigations of golf fairways	Not permitted.  Reuse water only

P6	Public gardens, council parks and reserves	Not permitted.

B1	Existing swimming pools and spas	Topping up permitted, if required to prevent structural damage or ensuring filter efficiency, between 4.00pm and 9.00am using hand-held hose fitted with an on/off nozzle.  Log of water use required.  Emptying and refilling of pools not permitted.	
B2	New swimming pools and spas	Permitted only if required to avoid structural damage or ensure filter efficiency.  Prior approval of Council is required.  Rainwater tank must be provided for pool/spa top-up.	
В3	Water play facilities, water parks	Operation or top up not permitted unless water is recirculated.  Log of water use required.	
B4	Fountains, ponds, water features, outdoor aquariums	Operation or top up not permitted except to maintain fish life.  Installation and filling of new facilities not permitted.	
B5	Irrigations of sports grounds, playing fields and golf fairways	Not permitted.	
В6	Cricket pitches, tennis courts, bowling greens, golf greens	Sprinklers or hand-held hoses permitted 15 minutes per day between 5.00am and 7.00am.  Alternative times to be approved by Council.	
В7	Garden watering	Not permitted.	
B8	Watering of established lawns	Not permitted.	
В9	Watering of new turf, lawns and gardens	Watering-in permitted for 30 minutes only on the day of establishment.  Then 15 minutes every second day, between 4.00pm and 9.00am on odd or even days matching house numbering system for 7 days after the date of establishment.	
B10	Pet care, animal husbandry	Provision of drinking water permitted.  Washing animals with buckets or hand-held hoses fitted with an on/off nozzle permitted between 4.00pm and 9.00am.  Cleaning of pens with high-pressure cleaning unit permitted.	
B11	Commercial car wash	Water must be recirculated and efficient high-pressure, low flow rate cleaners with trigger control are to be used.  Log water use required.	
B12	Motor vehicle dealers, car detailing/repairs	Buckets permitted.  Efficient high-pressure low flow rate cleaners with trigger control permitted every second day between 6.00am and 8.00am on odd or even days matching house numbering system.  Log water use required.
